CONTEST RULES AND REQUIREMENTS

Thank you for your interest in being Mr. BOLT Leather 2018! We're glad you've decided to apply and hope you're excited about competing. When you've read this application carefully and provided all the information requested, please deliver your application to The BOLT at the address shown below.

1. Contestants for Mr. BOLT Leather 2018 must be at least 21 years of age and must possess valid identification. Current employees of The BOLT are not eligible to enter the Mr. BOLT Leather 2018 contest.
2. During the contest, each contestant will:
 - a. Appear in each of the following three categories: (1) Bar/Casual Leather Wear, (2) Revealing Wear, and (3) Full Leather Wear.
 - b. Answer questions on-stage. Questions may be asked by contest judges and/or the Master of Ceremonies.
 - c. Produce a basket of prizes for auction and sell raffle tickets.
3. Contestants will be judged based on their general presence (i.e., how they present themselves throughout the entire weekend of the contest) and their participation in the above-listed activities. In the event of tied scores, raffle ticket sales will be the tie-breaker.

MR. BOLT LEATHER 2018 DUTIES

During his term as Mr. BOLT Leather 2018, the winner (Titleholder) will:

1. Strive to present a positive image to the community.
2. Produce a minimum of 3 events, either alone or in cooperation with The BOLT and/or other groups or individuals.
3. Represent Sacramento and The BOLT as a contestant in the 2018 International Mr. Leather contest in Chicago. The BOLT will act as sponsor, but the Titleholder will be responsible for raising funds for his trip to Chicago. Proceeds from the events mentioned above may be used for this purpose (see page 2).

Terms and Conditions

The following terms and conditions shall apply to the Titleholder of Mr. BOLT Leather 2018. Failure to abide by these terms and conditions will result in revocation of the title from the Titleholder, and in awarding of the title to the next runner-up.

➤ I have read, understood, and agreed with this provision: _____ (contestant's initials)

Ownership of Title: the title of Mr. BOLT Leather 2018 is the property of The BOLT and may be awarded or revoked at the discretion of The BOLT's owner. Title may be revoked at any time with or without cause. Cause for revocation of title includes, but is not limited to, failure by the Titleholder to present a positive image to the community.

➤ I have read, understood, and agreed with this provision: _____ (contestant's initials)

Concurrent Titles: during his term as Mr. BOLT Leather 2018, the Titleholder will not enter any contest for, or accept, any other elective or competitive title except for International Mr. Leather 2018. The Titleholder may accept honorary titles during his term as Mr. BOLT Leather 2018. The Titleholder may retain any titles he held at the time of his selection as Mr. BOLT Leather 2018.

➤ I have read, understood, and agreed with this provision: _____ (contestant's initials)

Term Limits: an individual may be Mr. BOLT Leather for more than one term, but no individual may be Mr. BOLT Leather for two consecutive terms. At least one term as Mr. BOLT Leather must be held by another individual before a previous Mr. BOLT Leather may compete for the title again.

➤ I have read, understood, and agreed with this provision: _____ (contestant's initials)

Events: during his term as Mr. BOLT Leather 2018, the Titleholder will produce a minimum of 3 fundraising events, either alone or in cooperation with The BOLT and/or other groups or individuals. Event planning and coordination will be conducted according to the directions of The BOLT's owner. Funds raised at the Titleholder's events will be split between the Travel Fund (see below) and a charity chosen by the Titleholder and/or The BOLT's owner. No less than 25% or more than 75% of funds raised at the Titleholder's events will be deposited into the Travel Fund. The Titleholder will promptly present all receipts, records of expenses or proceeds, and any other pertinent financial records to The BOLT's owner upon completion of each event.

➤ I have read, understood, and agreed with this provision: _____ (contestant's initials)

Travel Fund: the Titleholder will have access to the Mr. BOLT Leather Travel Fund. Proceeds from events held to benefit the Titleholder's travel to the 2018 International Mr. Leather (IML) contest will be deposited into this fund. Monies in the Travel Fund may only be used for the Titleholder's travel expenses to attend IML in Chicago, and possibly other leather events (see Travel Requirements below), upon approval of The BOLT's owner. Monies in the Travel Fund may not be used for any other purpose, including travel expenses of the Titleholder's partners, guests, or other persons, or for leather or equipment purchases. Monies in the Travel Fund are owned by The BOLT and not by the Titleholder. Any monies left in the Travel Fund at the end of the Titleholder's term as Mr. BOLT Leather 2018 will remain in the Travel Fund for use by Mr. BOLT Leather 2019.

➤ I have read, understood, and agreed with this provision: _____ (contestant's initials)

Travel Requirements: the Titleholder will represent Sacramento and The BOLT as a contestant in the 2018 IML contest in Chicago. The BOLT will act as sponsor, but the Titleholder will be responsible for raising funds for his trip to Chicago. The trip to IML could cost several thousand dollars depending on flight costs, hotel costs, etc. Covering these costs through the Travel Fund and/or personally is the Titleholder's responsibility. The BOLT does not directly fund the Titleholder's trip to IML. The Titleholder may choose to attend other leather events requiring travel in order to raise visibility and promote his term as Mr. BOLT Leather 2018, and funds from the Travel Fund may be used for this purpose upon prior approval of The BOLT's owner. However, covering the costs of the Titleholder's trip to IML is the primary purpose of the Travel Fund, and is the sole responsibility of the Titleholder.

➤ I have read, understood, and agreed with this provision: _____ (contestant's initials)
